1. The RSYC Committee has absolute discretion to:
 - a. approve or reject my application without assigning any reasons whatsoever. If my application is rejected then all application monies will be refunded (without any interest or other benefits arising there from) to us by ordinary post;
 - b. carry out subsequent launches for new memberships in such manner and on such terms as it deems fit.
 - c. alter the design plans, models, specifications, scale and scope of all or any of the Properties of the RSYC in such manner and on terms as it deems fit.
2. A Term Member shall not :-
 - a. be entitled to attend and/ or vote at General Meetings and/ or to hold office;
 - b. be entitled to propose and/ or second members and/ or candidates for office;
 - c. be liable for the debts of the Club; and
 - d. have any share and/ or claim in the property and/ or assets of the Club.
3. A Term Member is entitled to:-
 - a. full usage of clubhouse, bar, restaurant, social and the Marina facilities; and
 - b. signing privileges.

10. Term Membership (Non-Transferable) is for a period of 12 months from the date of approval of the membership application.
11. The RSYC reserves the right to terminate the Term Membership at any time prior to the expiry of the term referred to in clause (9) above by giving seven (7) days notice, Provided that if the termination is on grounds other than for breach of the Constitution, rules, bylaws and/ or the terms herein, RSYC shall refund to the Term Member all or part of the membership fees in the proportion of the Term to the period of the membership left remaining.
12. Upon receiving written confirmation from the RSYC that my application for Term Membership (Non-Transferable) has been accepted, I undertake to pay all monies due to the RSYC in accordance with the Constitution of the RSYC and to abide and be bound by the Constitution, such other rules, regulations or bylaws as may be prescribed by the RSYC Committee from time to time and all amendments thereto as well as all resolutions passed at the General Meetings of the RSYC.

 - f. if a bankruptcy petition is presented against me.

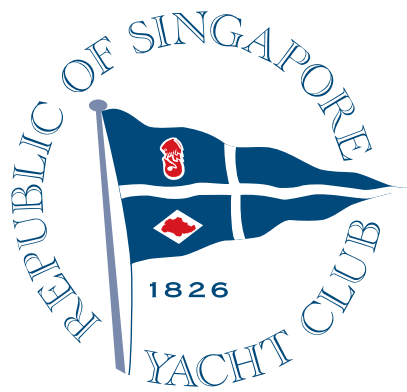
