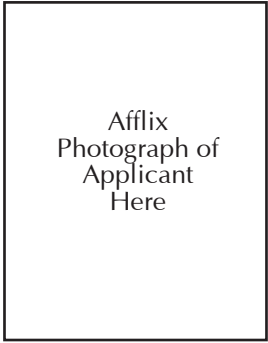

## TERMS & CONDITIONS

### Sailing Membership (Non-Transferable)

I agree to the following terms and conditions:

1. The RSYC Committee has absolute discretion to approve or reject my application without assigning any reasons whatsoever. If my application is rejected then all application monies will be refunded (without any interest or other benefits arising there from);
2. A Sailing Member shall:
  - a. be aged 21 years and above ;
  - b. not own or jointly own any vessel kept at the RSYC, other than a sailing dinghy or canoe;
  - c. be entitled to use the sailing, rowing and social facilities but not the power-boating facilities
  - d. be permitted to introduce up to two crew members who may only sail or row at the normal guest charge and who may use the RSYC facilities as may be determined by the RSYC Committee;
  - e. not be entitled to attend and vote at General Meetings or to hold office;
  - f. not be entitled to propose and second Members and candidates for office;
  - g. not be liable for the debts of the RSYC or share in the property and assets of RSYC
  - h. not be granted credit facility. All expenses will be settled via credit/debit card/NETS
  - g. not be granted Supplementary card for both spouse and children.
3. A Sailing Member is entitled to full usage of Clubhouse Social facilities, Marina Lodge and Marina facilities except the berthing facilities and Jackpot Room.
4. A Sailing Member must participate in two (2) Sailing Competitions representing RYC inclusive of RSYC Regatta
5. Loss of Sailing Membership card will be charged at \$25/card (excluding GST)
6. A Sailing Member may terminate or resign by giving notice in writing of one calendar month but shall continue to be liable for his full monthly subscription during the notice period.
7. As a Sailing member, you will be entitled to:
  - a. Register all Club's activities at Members' rate
  - b. Book Marina Lodge at Members' rate (For above 21 years of age)
  - c. Dine at all F&B outlets at Members' rate
  - d. Bring in one guest to the Swimming pool at no charge
  - e. Bring one guest to the Gymnasium @ \$10.70 per guest (for 16 years and above)
  - f. Rent any seasports equipment at Members' rate
8. No Entrance Fee is applicable. Monthly subscription fee will be applicable at \$100/month (excluding GST) that will be contributed to the Sailboat Maintenance fund.
9. Upon receiving written confirmation from the RSYC that my application for Sailing Membership (Non-Transferable) has been accepted, I undertake to pay all monies due to the RSYC in accordance with the Constitution of the RSYC and to abide and be bound by the Constitution, such other rules, regulations or bylaws as may be prescribed by the RSYC Committee from time to time and all amendments thereto as well as all resolutions passed at the General Meetings of the RSYC.
10. In accordance with the Constitution of the RSYC, a Member shall cease to be a Member and their names shall be removed from the List of Members of the RSYC in any of the following events:

A Member:

  - a. is convicted of any seizable offence or other offence involving dishonesty or violence; or
  - b. become an enemy alien; or
  - c. is expelled from RSYC; or
  - d. is adjudicated a bankrupt; or
  - e. becomes insane; or
  - f. if a bankruptcy petition is presented against me.
11. In compliance with the Personal Data Protection Act, information submitted through this form will
  - be used for marketing of RSYC's events and promotions to its members;
  - be used for marketing of products / offers from RSYC's selected partners;
  - not be shared with any third parties in any formats at any time;
  - be destroyed within 3 months upon termination / resignation of membership.
